Title: Requirements for Development within airside

General Direction Reference Code: CA – GD- 013 Date of Issue: 03rd May 2024

Pursuant to Section 121 of the Civil Aviation Act No.14 of 2010 which is hereinafter referred to as the CA Act, Director General of Civil Aviation shall have the power to issue, to all operators and license holders providing aeronautical services, any Special or General Directions in regard to any matter connected with or relating to the maintaining of public safety and welfare of the citizens of Sri Lanka.

Accordingly, I, being the Director General of Civil Aviation do hereby issue the General Direction on Requirements for Development within airside.

Theis General Direction shall be applicable to all the appointed aerodrome operators in Sri Lanka and shall come in to force from 03rd May 2024 and remain in force unless revised/revoked.

Attention is also drawn to section 103 of the Act, which states inter alia that failure to comply with a General Direction is an offence. Further, if any standard stipulate in this General Direction is not complied with or violated, an appropriate enforcement action will be taken as per the Aviation Enforcement Policy and Procedure Manual, SLCAP 005 by the Director General of Civil Aviation under Section 102 of the Act No. 14 of 2010.

1. Applicability.

This General direction shall be applicable to all the Aerodrome Operators in Sri Lanka appointed as service providers under Section 6(3) of the Civil Aviation Act No. 14 of 2010.

2. Purpose

It is imperative that effective resource allocation to ensure maximum utilization of limited resources within the airside through proper coordination among all stake holders.

3. Requirements by aerodrome operator.

The aerodrome operator shall obtain prior written approval from the DGCA for Airside developments in following circumstances,

- 1. Allocating lands for new development activities.
- 2. Sharing existing building space with any third party
- 3. Alterations to the existing facilities/ properties

Following details shall be submitted 30 days prior for review / evaluation of DGCA to satisfy himself prior to issue the written approval for ensuring safe, efficient and smooth functioning of airside operations in above listed situations,

- 1. Project specification.
- 2. Building plans/ sketches of the proposed development/alteration.
- 3. Google earth image with the location highlighted.
- 4. Risk assessment conducted by the aerodrome operator.
