

Documents/Requirements for Ad-Hoc Flight Operations to Sri Lanka

General

All the ad-hoc flights planning to operate to Sri Lanka must have prior authorization from the Civil Aviation Authority of Sri Lanka for the operation. The airline or the handling agent on behalf should submit all the documents and fulfill the requirements in order obtain the approval.

Due to several sections of the Authority involving for the evaluation of the documents, it is required to **submit all the documents along with the application at least 3 working days prior to the operation.**

All revenue ad-hoc flights (Passenger and Cargo) must obtained the approval for the operation by submitting following documents and requirements.
