Sealed Applications are invited for Aviation Medical Examiners (AME) on part time basis, initially for a period of one year at CAASL Head Office in Katunayake. The candidates should have the following Qualification and Experience.

## Qualification and Experience

- 1. Shall be a Citizen of Sri Lanka.
- 2. Medical Practitioner with MBBS or equivalent degree.
- 3. Registered with the Sri Lanka Medical Council with more than 5 years of post-internship experience.
- 4. Possess a basic qualification in Aviation Medicine and experience in the aviation field will be an additional qualification.
- a) The basic course for AMEs shall consist of sixty (60) hours theoretical and practical training, including specific examination techniques.
- b) Recommended Initial Aviation Medicine Training Programmes are;
  - i. Certificate of Aviation Medicine, Farnborough, UK
  - ii. Certificate of Aviation Medicine, Institute of Aviation Medicine, Bangalore, India
  - iii. Diploma in Aviation Medicine, D. Av. Royal College of Physicians, UK.
  - iv. Diploma in Aerospace Medicine, Pakistan.
  - v. Certificate in Civil Aviation Medicine, Monash University, Melbourne, Australia
  - vi. Any other Aviation Medicine training programme which is recognized by CAASL after an evaluation of the programme and the institute/University.
- 5. Experience in practicing Aviation medicine, or aviation related organizations would be desirable.
- 6. Availability during the day time for consultation at least one day a week or as and when required.

## Scope of Work

Aviation Medical Examiners (AME) are required to carry out Medical Examinations of CAASL License Holders on behalf of Aeromedical Services of CAASL. For further information and remuneration details, please visit the CAASL official web site at <u>www.caa.lk</u>.

- Applicants are required to forward complete resume with copies of documentary evidence for qualifications and experience to prove your eligibility.
- Applicants should be less than 65 years.
