CIVIL AVIATION ACT, No. 14 OF 2010

REGULATION made by the Minister of Civil Aviation by virtue of the powers vested in him under Section 117(2) (s) of Civil Aviation Act, No. 14 of 2010.

Regulations

Pursuant to Section 117 (2) (s) of Civil Aviation Act, No. 14 of 2010 the Minister of Civil Aviation has made the following regulations relating to fees to be levied for the issue, validation, renewal, extension, revalidation, or amendment of any licence, certificate, permit, approval or any other form of legal authority or document to be granted or any other service to be rendered either by the Civil Aviation Authority of Sri Lanka or Director General of Civil Aviation.

- 1. These Regulations may be cited as "Civil Aviation Authority Fees and Charges Regulation No. 01 of 2014" and shall come into force with effect from 01st August, 2014.
- 2. The fees to be levied for the issue, validation, renewal, extension or amendment of any licence, certificate, permit, approval or any other form of legal authority or document to be granted or any other service to be rendered either by Civil Aviation Authority of Sri Lanka or Director General or Civil Aviation shall be as specified in the Schedule hereto.
- 3. The money to be collected either by the Civil Aviation Authority of Sri Lanka or Director General of Civil Aviation in the form of fees and charges under this Regulation, shall be credited to the Civil Aviation Authority Fund as provided under Section 12 of the Civil Aviation Authority of Sri Lanka Act, No. 34 of 2002.
 - 4. The following Regulations are hereby repealed with immediate effect.
 - (a) Air Navigation Regulations published in the Government Gazette (Extra Ordinary) No. 1025/6 dated 28th April, 1998;
 - (b) Air Transport Providers (Passengers) Licensing Regulations published in the Government Gazette No. 1298/21 dated 22nd July, 2003;
- 5. Any Rule issued by the Civil Aviation Authority of Sri Lanka or any implementing Standard issued by the Director General of Civil Aviation in respect of fees or charges to be levied by the Civil Aviation Authority of Sri Lanka for any service rendered is superseded by these Regulations.

SCHEDULE

- 1. Any applicant seeking facilities or services mentioned below shall furnish to the Civil Aviation Authority of Sri Lanka all applicable information as required by the Civil Aviation Authority or Director General of Civil Aviation together with the fees mentioned below, at the time of submitting the application.
- 2. An applicant shall, in addition to the fees mentioned below, bear the full cost of air passage, hotel accommodation and daily subsistence allowance at the approved rate for the officials whom the Civil Aviation Authority of Sri Lanka may have to engage to perform any work overseas in relating to the application. The cost of air passage is calculated on the basis of full fare economy class seat round trip if the flight time is less than six hours. For trip involving flight time of six hours or more the cost of passage will be calculated in the basis of full fare business class round trip.
- 3. Fees chargeable under these Regulations are not refundable, unless otherwise decided by the Director General of Civil Aviation and Chief Executive Officer.
